Application is hereby made by the undersigned Exhibitor for exhibit space at the 7th Annual Love of Labs, Indiana (LOLIN) Labapalooza ("Event") to be held at Mallow Run Winery, Bargersville, Indiana on Sunday, September 10, 2017.

NEW - A limited number of 10x10 booth spaces will be approved. Limit may be reached before deadline. Send contract and payment early to ensure availability.

The Exhibitor certifies that the printed matter on the Application and Contract for Exhibit Space along with the Rules and Regulations constitutes the entire Agreement between the parties and has been read and that the terms and conditions set forth therein are fully understood by the Exhibitor and shall constitute a binding contract when this instrument is signed by both parties. Exhibitor must include payment with application.

Exhibitor Rules and Regulations

- 1. Exhibit Contract.** It is understood and agreed that this is an application only until accepted in writing by Love of Labs, Indiana (LOLIN). It is also understood and agreed by undersigned Exhibitor that after the acceptance and approval of this application, said application should become a contract between Exhibitor and Love of Labs, Indiana (LOLIN). Here forth referred to as Love of Labs, Indiana (LOLIN). The Exhibitor agrees to pay promptly all rentals when due and to abide by the terms and regulations below.
- 2. Rules and Regulations.** Any violation of any of the terms and conditions of these rules and regulations on the part of any Exhibitor will be cause to terminate the Agreement to occupy space, and such Exhibitor will forfeit to Love of Labs, Indiana (LOLIN) all monies which may have been paid. In case of any violation of the terms and conditions of these rules and regulations on the part of the Exhibitor, right is hereby given to Love of Labs, Indiana (LOLIN), to terminate the contract to occupy space, at its option, and Love of Labs, Indiana (LOLIN) may re-enter and take possession of the space occupied by the Exhibitor, and remove all persons and goods at the Exhibitor's own risk, without liability of Love of Labs, Indiana (LOLIN) therefore.
- 3. Subletting.** Subletting of contracted exhibit space is **NOT** permitted. Special arrangements must be made **in advance** for two or more Exhibitors occupying the same exhibit space.
- 4. Booth Space.** *Booths are assigned on a first-come first-serve basis, full payment and application received. Assigned booth space may not be level. Exhibitor must provide their own leveling devices, table(s), chair(s), canopy or tent, table covers and water. Booths are expected to be attractive and kept clean throughout the day.* All decisions involving Exhibitors and booth placement made by the Love of Labs, Indiana (LOLIN) shall be final.
- 5. Loss Liability.** Love of Labs, Indiana (LOLIN) and/or Mallow Run Winery shall not be held responsible for any loss or damage that may result from robbery, theft, fire, strikes, accidents or other destructive causes. Love of Labs, Indiana (LOLIN) coverage does not extend to Exhibitor's property.
- 6. Restriction.** Love of Labs, Indiana (LOLIN) reserves the right to refuse any space application, or to evict any exhibit which in the opinion of Love of Labs, Indiana (LOLIN) may detract from the general character of the Event as a whole.
- 8. Licenses/Permits/Taxes.** Exhibitors shall be responsible for obtaining any licenses, permits, or approvals required under local and state law applicable to their activity at the Event. Exhibitors shall be responsible for obtaining any tax identification numbers and paying all taxes, license fees or other charges that shall become due to any government authority in connection with their activities at the Event. In the event that this space agreement is subject to any federal, state, or municipal taxes, or other tax now or hereafter enacted, the amount of such tax shall be added to the price above agreed.
- 9. Additional Insurance.** Exhibitor shall certify, at its expense, the provision of insurance for protection of their property against fire, theft, vandalism or destruction by any cause. Love of Labs, Indiana (LOLIN) assumes no risk by the acceptance of this agreement. Exhibitors expressly release Love of Labs, Indiana (LOLIN) from any and all liability for any damage, injury or loss to any person or goods, which may arise from the rental, and occupation of said space. Exhibitors agree to hold and save Love of Labs, Indiana (LOLIN) harmless of and from any loss or damage by reason thereof.
- 10. Management.** Any matters not covered by these rules are subject to the sole discretion of Love of Labs, Indiana (LOLIN).
- 11. Removal of Exhibit.** At the close of the event, if Exhibitor owes Love of Labs, Indiana (LOLIN) any sums arising hereunder, or if Exhibitor fails to remove an exhibit, equipment or paraphernalia at the time determined by Love of Labs, Indiana (LOLIN), Love of Labs, Indiana (LOLIN) is hereby given permission by Exhibitor to take immediate possession of Exhibitor's exhibit, equipment or paraphernalia. Same may be removed, sold at public sale or private sale with or without notice to Exhibitor, and without relief from valuation or appraisal laws, in order to defray any sums due Love of Labs, Indiana or to pay removal costs. No dismantling or removal of booths is permitted prior to the official announced closing time on final day of show. Exhibitor acknowledges that in the event it dismantles or removes its booth(s) prior to the announced closing, the event as well as other exhibitors may be harmed. The damages suffered if such an event were to occur would be uncertain and difficult to ascertain. Exhibitor thereby agrees to pay Love of Labs, Indiana (LOLIN) liquidated damages for unauthorized dismantling or removal of its exhibit, a sum equal to the total booth space cost Exhibitor paid for this event. Exhibitor acknowledges that the sum indicated as liquidated damages is not unreasonable and should not be considered a penalty.
- 12. Impossibility of Performance.** Love of Labs, Indiana (LOLIN) will not be liable for the fulfillment of this Agreement as to the delivery of space. The parties agree that it is foreseeable that the Event may be cancelled due to fire, acts of God, public enemy, war or insurrections, strikes, the authority of the law, postponement or cancellation of the Event, or any other cause beyond Love of Labs, Indiana (LOLIN)'s control. Therefore, the Exhibitor agrees that in the event the Event is cancelled by reason of acts of God, strike, lockouts, acts of the elements, or other acts or occurrences beyond Love of Labs, Indiana (LOLIN)'s control, the Exhibitor shall not have any right of claim for refund against Love of Labs, Indiana (LOLIN) for monies paid by the Exhibitor pursuant to this contract. Love of Labs, Indiana (LOLIN) will, however, in the event of not being able to deliver space for any of the foregoing reasons, attempt to reimburse Exhibitor for any amount paid, less any and all reasonable expenses incurred by Love of Labs, Indiana (LOLIN) for advertising, salaries, operating expenses, etc.
- 13. Attorney Fees.** In the event Exhibitor defaults in the performance or observance of any of the terms and regulations contained in this Agreement, and/or Love of Labs, Indiana (LOLIN) employs attorneys to enforce all or any part of this Agreement, Exhibitor shall reimburse Love of Labs, Indiana (LOLIN) for the attorney fees and court costs incurred, whether or not suit is actually filed.
- 14. Governing Law.** This agreement shall be governed in accordance with the laws of the State of Indiana. Should Love of Labs, Indiana (LOLIN) commence or maintain litigation to enforce the Agreement, Exhibitor agrees to submit itself to the jurisdiction of the courts of Johnson County, Indiana, for the purpose of such litigation and hereby waives any objection it might have to such litigation been commenced or maintained in the courts of Johnson County, Indiana, on the basis of lack of subject matter jurisdiction, lack of personal jurisdiction, improper venue or inconvenient forum.
- 15. Assembly/Staffing/Dismantling.** Exhibits must be set up and operational no later than 12:30 pm on day of event, without exception. Exhibit booth(s) must be staffed during Event hours. Dismantling of booth(s) is not permitted until the close of Event.
- 16. Live Animal Exhibits.** Exhibits with animals must have all licenses, permits and vaccinations required by the City, State or Federal government bodies with jurisdiction over the display, care and handling of such animals. All dogs and cats must be spayed or neutered. Love of Labs, Indiana (LOLIN) reserves the right to approve any animal or the display of any animal at the event. Any animal at the event or its agents deem unhealthy, not cared for, too dangerous or in any other way

not satisfactory for display at the Event must be immediately removed from the Event by the Exhibitor upon notification. No animals may be sold on premises. Exhibitors are responsible for removal of pet waste, food and other related materials to the approved waste receptacles.

17. **Sales Guidelines.** Exhibitor must display merchandise within the designated booth area.
